| 1 | SELINA AMUSILIE ABALANSA | <p>Amusilie Selina Abalansa was charged for breach of Article 11(1) of the GFA Disciplinary Code, 2019 in respect to Physical abuse of Referee Cynthia Anafo.</p> <p>She was also charged for a breach of Article 12(1)i of the GFA Disciplinary Code for unsporting behavior towards a match official, 12(1)j of the GFA Disciplinary Code, 2019 in respect to intimidation of a match official and Article 12(1)k of the GFA Disciplinary Code, 2019 in respect to physical assault of a match official.</p> | <p>In a written Statement of Defence, Amusilie Selina Abalansa pleaded Guilty to all charges against her.</p> <p>She admitted that her actions were unsportsmanlike and unwarranted.</p> <p>She however pleaded for mitigation.</p> | <p>The Committee therefore, makes the following decisions:</p> <ol style="list-style-type: none">1. That in accordance with Article 6.2(a) of the GFA Disciplinary Code, Amusilie Selina Abalansa is suspended with immediate effect for a period of one (1) year or until the second registration window of the 2022/23 football season (which ever comes first)2. That in accordance with Article 6.1(c) of the GFA Disciplinary Code, a fine of GHc500 is imposed on Amulisie Selina Abalansa3. That Amulisie Selina |

| 2 | KASSIM OCANSEY MINGLE | <p>Kassim Ocansey Mingle was charged for a breach of Article 38(8)(c) of the GFA Premier League Regulations.</p> <p>According to the Charge Sheet, after the Ghana Premier League match between Accra Great Olympics FC and Bechem United, Kassim Ocansey Mingle did accuse the match officials that they have been robbing your club whenever you play away games and labeled the referees performance as ‘complete robbery’, a statement that you made without proof.</p> | <p>In a written statement of defense, Kassim Ocansey Mingle apologized for his choice of diction during the said post-match interview.</p> <p>He attached videos of incidents he was referring to in the interview</p> <p>He apologised for the choice of words used during the post-match interview if the FA finds it offensive.</p> | <p>The Committee therefore, makes the following decisions:</p> <ol style="list-style-type: none"> 1. That in accordance with Article 6.1(c) of the GFA Disciplinary Code, a fine of GHc1000 is imposed on Kassim Ocansey Mingle. 2. That Kassim Mingle Ocansey is warned that any future misconduct shall receive a more severe punishment. |
